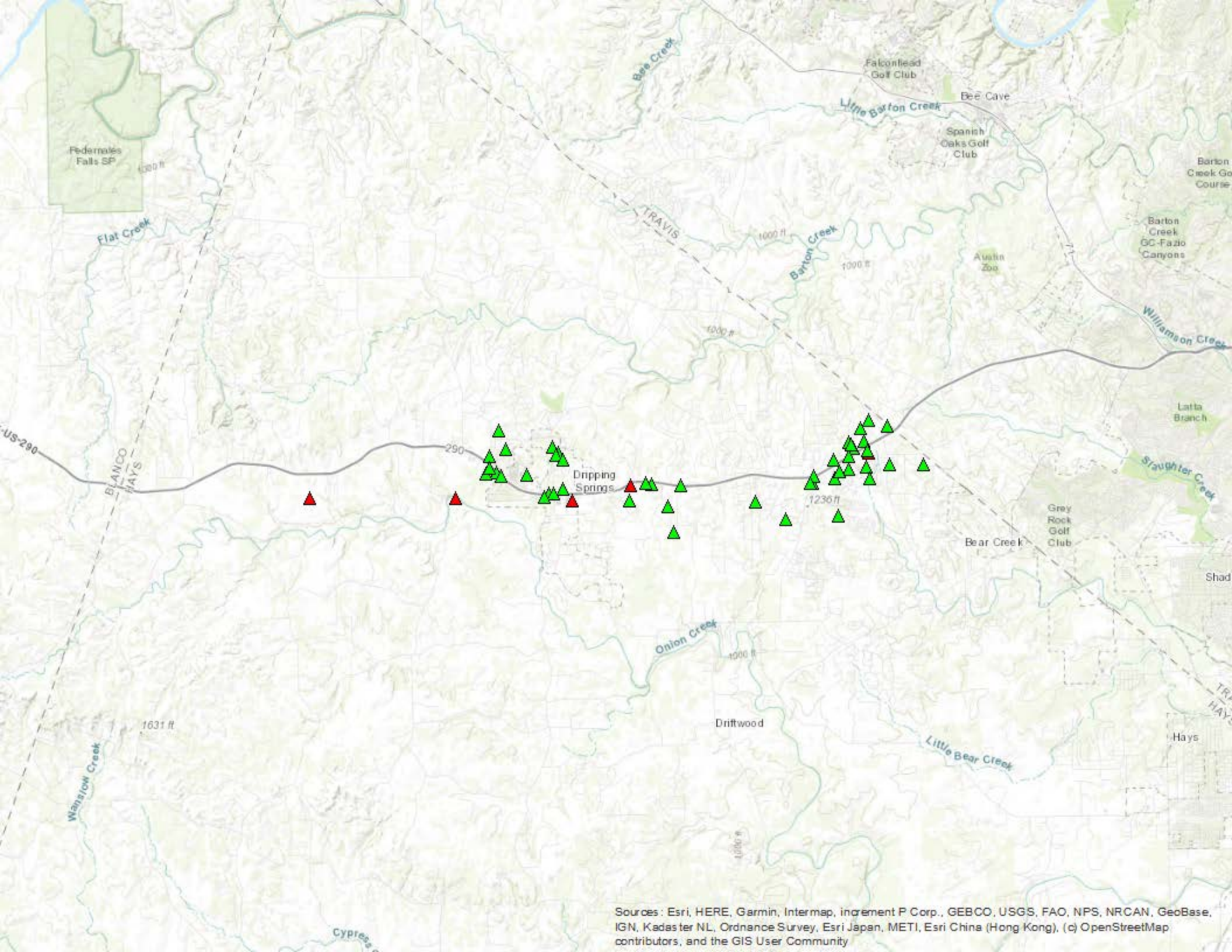
NHC ESD #1 Primary Coverage Area Level Zero Data March 1st, 2019 to March 31st, 2020



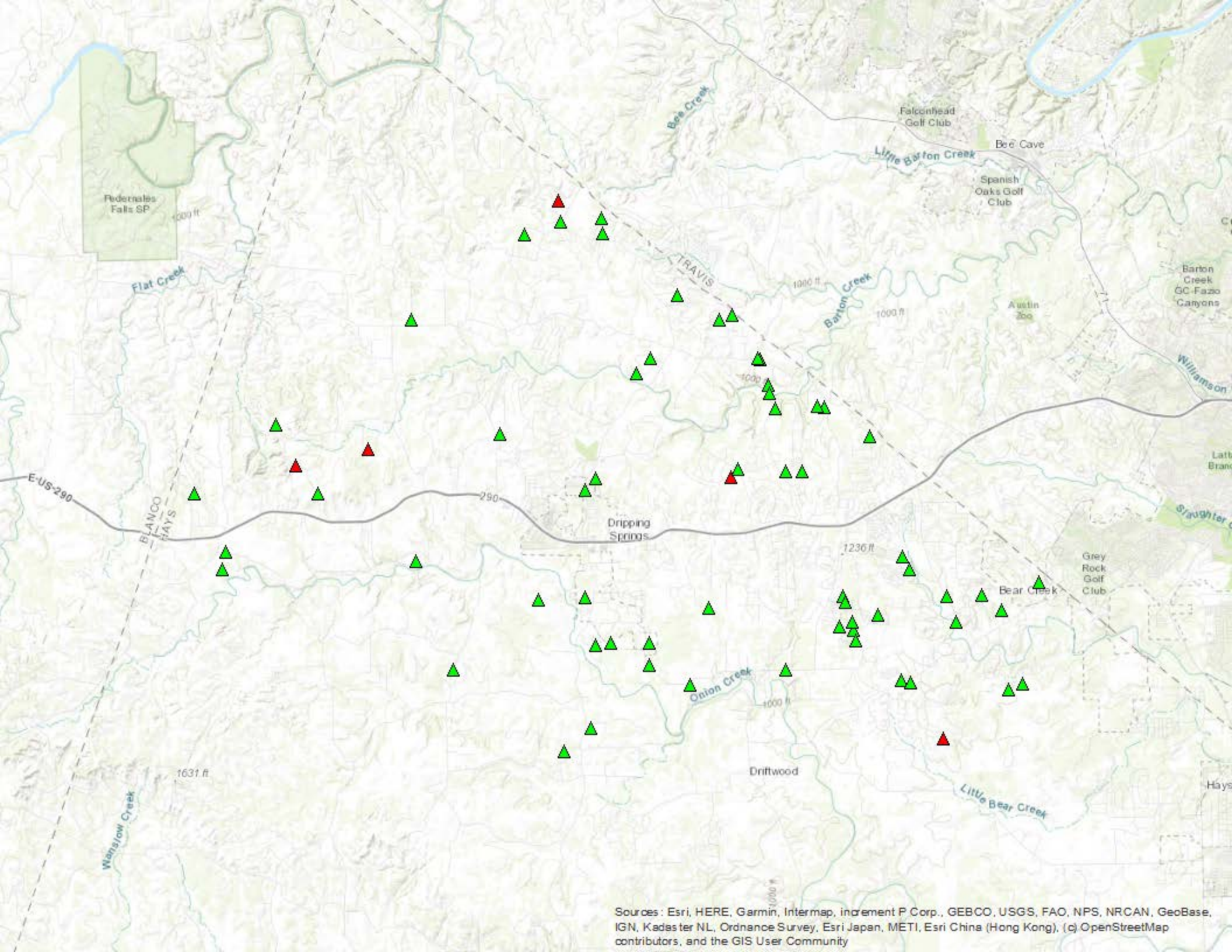
