M71 & M72 Primary Coverage Area Level Zero Data November 1st, 2018 to November 30th, 2019

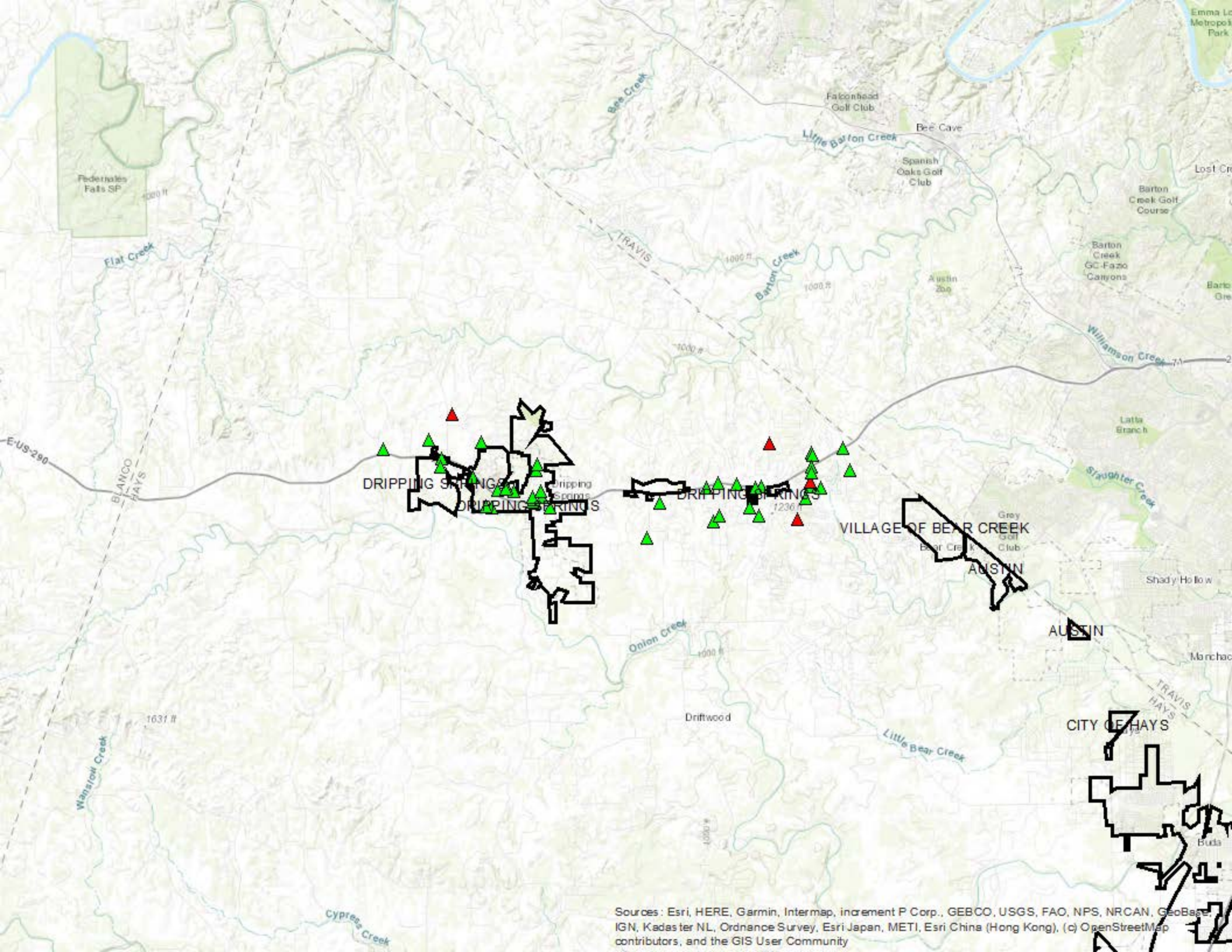

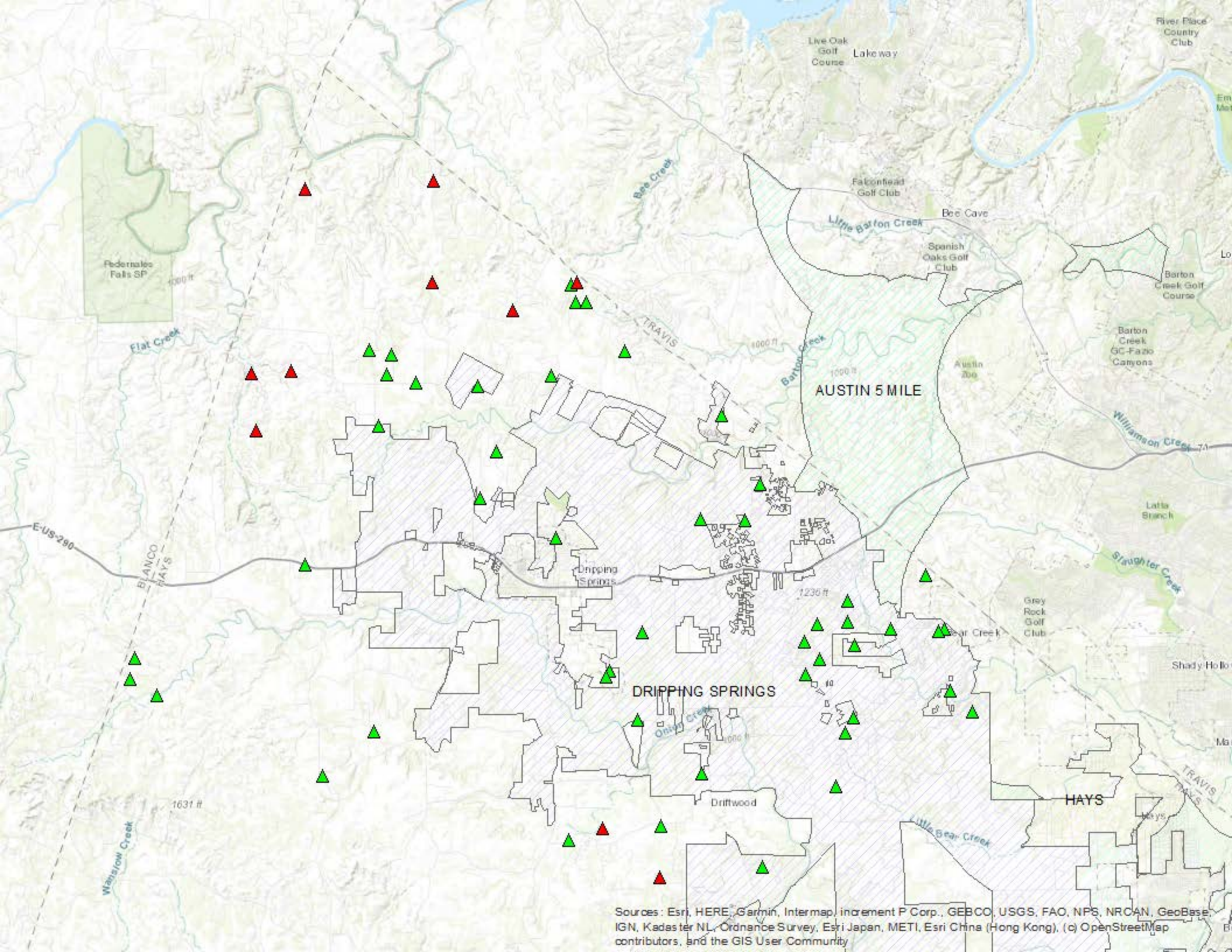
